**DECISION No. 1**  
city of Sofia, 10.12.2012

IN THE NAME OF THE PEOPLE

**SOFIA CITY COURT, CORPORATE DEPARTMENT**, 2<sup>nd</sup> panel, in a closed session held on 10.12.2012,

CHAIRPERSON: Desislava Dobрева

after hearing corporate case No. 775/2012, and in order to rule, took into consideration the following:

The proceeding is initiated under Art. 595 et seq. of the Civil Procedure Code based on application under Art. 6, Art. 17 and Art. 18 of the Non-Profit Legal Entities Act /SG issue 81/06.10.2000/.

It was initiated on the occasion of the application filed by the persons identified as per Art. 34, Para 3, requesting the foundation to be entered with the court's special registry of non-profit legal entities.

Based on the written evidence provided in support of the case, the court finds as established the following factual and legal circumstances:

The Deed of Incorporation dated 21.11.2012, notary certified under the hypothesis of Art. 33, Para 2, proves that the foundation named "LITTLE DREAMER FOUNDATION" has been established pre-mortem. For the foundation's establishment, property has been gratuitously provided with the purpose of achieving the non-profit goals, as specifically itemized in Art. 6 of the Deed of Incorporation.

The Deed of Incorporation meets the requirements of Art. 34 of the Non-Profit Legal Entities Act. The bodies and representation of the company have been specified. The goals, as stated by the organization, define it as an organization devoted to carrying out activity for



the public good. The goals do not fall within the category of goals prohibited by the country's laws and constitution.

With a view to the above, having established the existence of all circumstances subject to entry, and having accepted that their entry is allowable on the grounds of Art. 602, Para 2 of the Civil Procedure Code in relation to Art. 6, Para 1 and Art. 18 of the Non-Profit Legal Entities Act,

**RULED:**

Enters in the registry of non-profit legal entities a foundation named:

“LITTLE DREAMER FOUNDATION”

with seat and registered address in the city of Sofia, Vitosha Region, Simeonovo r.d., 10, 50<sup>th</sup> Street,

with **GOALS:** Organizing educational courses, creating camp schools; resident programs for working with children, including, but not limited to, organizing trips and cruises; participation in projects and pre-project programs and funds. **Means for achieving the goals:** To achieve its goals, the foundation may use all activities permitted by law, including, but not limited to: planning the allocation of funds from the constituent donation, other donations and bequests with a view to the optimal realization of the Foundation's goals.

The Foundation shall be of indefinite duration.

**The Foundation has been established to carry out activity for the public good.**

**The Foundation shall have the following scope of activity:** developing and confirming the spiritual values, civil society, education, science, culture, technics, technologies, and physical culture; supporting children in need of care, and supporting the social integration and personal fulfillment.

The Foundation has been established by the act of donating 500 BGN.

Managing bodies – Managing Board comprising: SILVI GEORGIEV DAMYANOV, Personal No. xxxxxxxxxxxx – Chairman, DESISLAVA HRISTOVA DAMYANOVA, Personal No. xxxxxxxxxxxx, and VALENTIN ALEKSANDROV DIMITROV, Personal No. xxxxxxxxxxxx

Pursuant to the provisions of Art. 14 of the Articles of Incorporation, the Foundation shall be represented by the Chairman SILVI GEORGIEV DAMYANOV, Personal No. xxxxxxxxxxxx

The decision shall not be subject to appeal.
